**Sub: Disclosure under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.**

This is in continuation to our previous intimations dated December 02, 2023 and December 15, 2023. We had intimated the exchange of the order of the Hon'ble High Court of Madras which directed the respondents to deposit a sum of Rs 5 Crores (Rupees Five Crores Only) and the Interim Stay obtained by way of an Order dated December 13, 2023 reducing the amount to be deposited to Rs. 1 Crore (Rupees One Crore only).

We had also intimated that the Award Holders and the Judgement Debtor had separately challenged the Madras High Court order dated 05.01.2023 before the Hon'ble Supreme Court. Now that we have received a copy of the Order in this connection, we would like to give an update on the same.

In pursuance to SEBI circular numbered SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, additional details to be disclosed regarding the aforesaid order is annexed in **Annexure I** to this intimation.

The impugned Order dated 22/11/2023 was challenged before the Division Bench of the Hon'ble High Court and the Hon'ble High Court granted an Interim Stay on the Order dated 22/11/2023 on Condition that the Appellant depositing a sum of Rs.1.00 Crore (Rupees One Crore Only) to the credit of OSA (CAD) No: 163 of 2023 on or before 14/12/2023 as per the copy of the order received by us on December 15, 2023.</p> <p>Further the Award Holders and the Judgement Debtor had separately challenged the Madras High Court order dated 05.01.2023 before the Hon'ble Supreme Cour and the Hon'ble Supreme Court vide its Order dated. 14.12.2023, copy received by us on 16.12.2023 permitted to tag with the SLP filed by the "GPE (India) Ltd.&amp; Others along with the SLP filed by Tiwari Consultancy Service Private Limited &amp; Another".</p> <p>Thus, the matter is sub judice before the Hon'ble High Court of Madras and the Hon'ble Supreme Court and the Arbitral Award as such has not attained finality.</p> <p>In any event, there would not arise any financial impact on this Company as it stands fully indemnified against any matters arising out of the Arbitral Award in terms of the Indemnification agreement dated 29th September 2015 with Twarit Consultancy Services Private Limited and Shri Housing Private Limited.</p>
