The Company is providing e-voting facility for voting electronically / remote e-voting on the Resolution proposed in this Postal Ballot Notice. Accordingly, members can cast their vote electronically through the CDSL e-voting platform. Remote e-voting will commence at 9.00 A.M. IST on October 14, 2025 and will end at 5.00 P.M. IST on November 12, 2025. Members are requested to read the instructions in the Notes in this Postal Ballot Notice so as to cast their vote electronically and are requested to cast their vote before 5.00 P.M. IST on Wednesday, November 12, 2025.

- (i) The remote e-voting period begins on **Tuesday, October 14, 2025 at 09:00 A.M.** and ends on **Wednesday, November 12, 2025 at 5.00 P.M.** During this period, Members holding shares either in physical form or in dematerialized form, as on the cut-off date i.e., October 08, 2025 may cast their vote electronically. The remote e-voting module shall be disabled by CDSL for voting thereafter.
- (ii) Pursuant to SEBI Circular No. SEBI/HO/CFD/CMD/CIR/P/2020/242 dated 09.12.2020, under Regulation 44 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, listed entities are required to provide remote e-voting facility to its shareholders, in respect of all shareholders' Resolution. However, it has been observed that the participation by the public non-institutional shareholders/retail shareholders is at a negligible level. There are also multiple e-voting service providers (ESPs) providing e-voting facility to listed entities in India which necessitates registration on various ESPs and maintenance of multiple user IDs and passwords by the shareholders.

In order to increase the efficiency of the voting process, pursuant to a public consultation, it has been decided to enable e-voting to all the demat account holders, by way of a single login credential, through their demat accounts/ websites of Depositories/ Depository participants. Demat account holders would be able to cast their vote without having to register again with the ESPs, thereby, not only facilitating seamless authentication but also enhancing ease and convenience of participating in e-voting process.

EXPLANATORY STATEMENT IN RESPECT OF THE SPECIAL BUSINESS PURSUANT TO SECTION 102 OF THE COMPANIES ACT, 2013.

The following explanatory statement sets out all material facts relating to the special business mentioned in the accompanying notice and shall be taken as forming part of the Notice.

Item No. 1: To consider and approve the re-designation of Mr. Venkataramani Jaiganesh (DIN: 00095975), Whole-Time Director (Key Managerial Personnel) as Managing Director of the Company.

The Board of Directors of the Company in its meeting held on July 14, 2025 approved the appointment of Mr. Venkataramani Jaiganesh (DIN: 00095975) as the Whole-Time Director of the Company with effect from July 14, 2025 for a term of five years. Subsequently, the shareholders approved the appointment at the Annual General Meeting held on September 29, 2025.
