During the audit period, we observed that one of the Designated Person of the company has traded in the shares of the Listed Entity while trading window was closed, executed contra trade and shares were traded without obtaining preclearance which is in violation of SEBI (Prohibition of Insider Trading) Regulations, 2015 and Company's Code of Conduct to Regulate, Monitor and Report trading by designated persons. In relation to the same, the Board of directors in accordance with the Company's Code of Conduct to Regulate, Monitor and Report trading by designated persons has imposed a penalty of Rs 10,00,000 (Rs. Ten Lakhs only) to the designated person and remitted the same to SEBI administered Investor Protection and Education Fund and reported the aforesaid violation to the stock exchanges on September 16, 2023 in compliance with SEBI circular numbered SEBI/HO/ISD/CIR/P/20 dated July 23, 2020.
